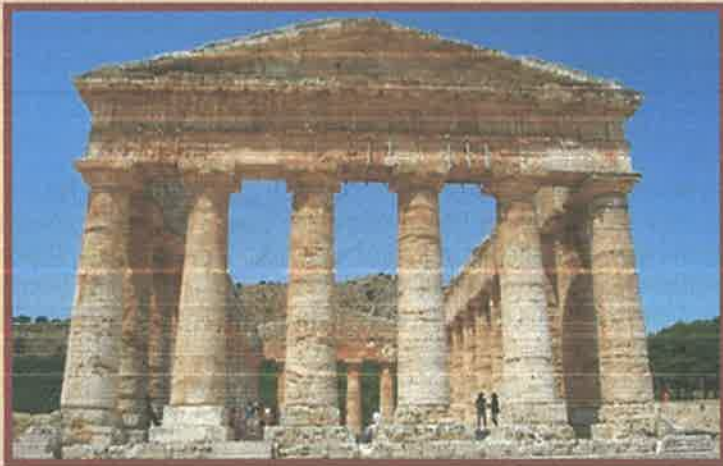

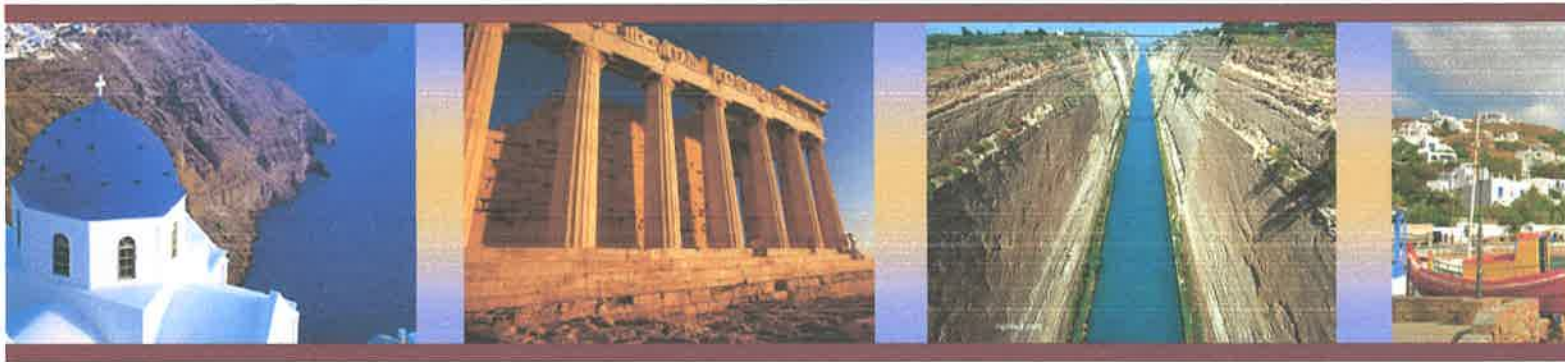

Day 01 – Saturday, April 18: Depart U.S.A.

Embark upon your journey to the lands of ancient treasures and Christian history with an overnight flight to Thessaloniki. Prepare yourself for a lifechanging experience and get some rest on the flight. Tomorrow we will be walking in the Greek world that the Apostle Paul knew. The world and culture of the New Testament is about to come alive!

Day 02 – Sunday, April 19: Arrive in Thessaloniki

We arrive in Thessaloniki, the city where Paul was received by Jason. Paul was preaching the Word of God here until he was rushed out of the city. We transfer to our hotel for dinner and overnight. Overnight @ City Hotel Thessaloniki (D)

Day 03 – Monday, April 20: Full day tour of Thessaloniki

This morning visit the city of Thessaloniki, Greece's second largest city and capital of Macedonia, highlight treasures of the ancient Byzantine and medieval eras. Included are the famous Byzantine St. Dimitri Church, Vlatadon Monastery, the University and Arch of Galerius. Visit the Archaeological Museum exhibition all treasures recently found in Vergina by Manolis Andronikos. Dinner and overnight at hotel. Overnight @ City Hotel Thessaloniki (B, D)

Day 04 – Tuesday, April 21: Amphipolis, Philippi, Kavala, Thessaloniki

This morning, we travel east to the amazing site of Philippi. On the way we will make a brief stop at Amphipolis. Paul stopped here on his way to Thessalonica (Acts 17:1). Arriving at Philippi, we visit the Baptistry of Lydia, near the river where Paul baptized her. Lydia was the first convert of Paul on European soil, followed by the conversion of the jailer. We also visit the ruins of the Forum of Philippi, the Christ a Basilicas, the "Prison of Paul" and the Theater. We then drive to the coast, to the port of Kavala (ancient Neapolis). Here, Paul took his first step in bringing the Gospel to present day Europe. It is a picturesque port! We view the Byzantine Castle and the Roman Aqueduct. To end the day, we drive back to Thessaloniki for dinner. Overnight @ City Hotel Thessaloniki (B, D)

Day 05 – Wednesday, April 22: Berea, Vergina, Kalambaka

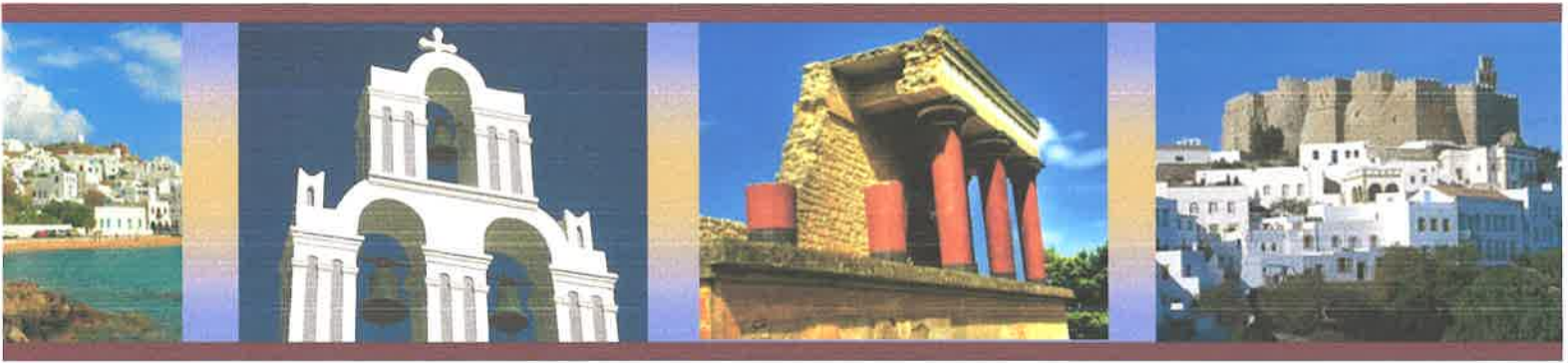
This morning, we tour the city of Thessaloniki. We'll see the White Tower, the Agora, and the Church of St. Demetrius. We will also gain a panoramic view from the upper part of the city before leaving Thessaloniki. From here, we drive south through the beautiful landscape of inland Greece. We make a brief stop in Berea, visited by Paul (Acts 17 - 10f). It was here that Paul planted a church that "studied the Scriptures" on a regular basis. Close by is Vergina, the burial place of Philip II (Father of Alexander the great), now a museum. In the afternoon, we drive through the scenic route over the mountains to Kalambaka. Weather permitting, we might see Mt. Olympus, the legendary abode of the Greek gods. In the late afternoon, we arrive at Meteora. We spend the night in Kalambaka, located in the shadows of the unique monasteries of Meteora. Overnight @ Grand Meteora Kalambaka. (B, D)

Day 06 – Thursday, April 23: Meteora Monasteries – Thermopylae

We leave the hotel after breakfast and visit two (2) of the Meteora Monasteries. Here, we will see the famous Byzantine monasteries that are perched precariously on summits of gray rock pinnacles of varied and beautiful shapes. Their history goes back to the 14th century when the monks sought refuge in the cliff-side caves. Then they fled higher to build the original wooden shelters, which were later transformed into monasteries. Continue with drive to Thermopylae. It was here that the famous 300 Spartans, led by King Leonidas, fought with an alliance of Greek city-states against the large Persian army in 480 B.C. From here we drive to Athens for dinner and overnight at our hotel. Overnight @ Divani Palace Acropolis. (B, D)

Day 07 – Friday, April 24: Athens, Acropolis, Mars Hill, the Plaka

After breakfast we depart for Athens City Tour. We climb the world-renowned Acropolis, to see the *Propylaea*, the Erechtheum and the Parthenon. Next, we visit Mars Hill, where Paul delivered his speech on the Unknown God. Then we see the Agora, the ancient center of the economic and public life of the city, where Paul preached to the skeptical Athenians. During the bus tour, we also see Constitution Square with the House of Parliament and the Tomb of the Unknown Soldier, the Temple of Zeus, the Old Olympic Stadium, and the Neoclassical Buildings of Athens. In the afternoon, we will enjoy some free time in the Plaka, Athens market. We'll grab a gyro or a Greek salad for lunch before we meet at a designated area. Return to the Hotel – Free evening, Dinner at the Hotel. Overnight @ Divani Palace Acropolis (B, D)



Day 08 – Saturday, April 25: Full day Ancient Corinth – Mycenae

We start the day by visiting the site of Mycenae, the legendary city rival of Troy, and described by Homer as “Mycenae rich in Gold.” This city dates back to the late Bronze Age and is famous for the “beehive” Tomb of Agamemnon (Treasury of Atreus) and the gold masks. Lunch at local restaurant. We then continue to ancient Corinth. This is the once glorious city near the Isthmus, where Paul met Aquila and Priscilla and spent a year and a half preaching the Word of God. We visit the Archaeological Museum, the Forum, the Temple of Apollo, the Roman forum, and the famous Bema where Paul stood before Gallio, accused by the Jews of Corinth. We also will try to see the acropolis of the city and the Temple of Aphrodite. Then we make a brief stop to Cenchreae, the small harbor from which Paul sailed back to Asia. Upon arriving back in Athens, we'll enjoy dinner together at our hotel. Overnight @ Divani Palace Acropolis (B, D)

Day 09 – Sunday, April 26: Athens/ Rome

After breakfast we will be transferred to Athens Airport for our flight to Rome our home for the next four nights. We are met by our tour manager and after some free time for lunch in the afternoon we will have a guided panorama tour of her sites before the check in at the Hotel. Dinner and overnight at the Hotel. (B, D)

Day 10 – Monday, April 27: Coliseum, Forum, Mamertine Prisons

After breakfast, this morning we move to the city center and we start our walking tour at the ancient Roman Forum, where our guide will divulge its secrets. We will visit the Arch of Titus which commemorated the sack of Jerusalem by Titus in AD 70. We will step inside the Mamertine Prison, where tradition says the Apostle Paul was imprisoned. The Roman church would say that Peter was imprisoned here as well, but there is no imperial evidence that Peter was ever in Rome. Next, we visit the Coliseum, where thousands of people and animals perished during gladiatorial games. The Coliseum first opened in AD 80 and within 100 days of its opening, 5000 wild beasts perished here. The slaughter of both humans and animals continued for three more centuries. Historians believe the Coliseum could hold between 40,000 and 80,000 people depending on how close the seating was. The floor has recently had a plank placed over the middle making it accessible for people to walk over the labyrinth of brick cells, ramps, and elevators used to transport animals and gladiators into the arena. Hear the stories of the games that have fascinated people for years. Free time for lunch and for browsing this fascinating city. Return at the Hotel for dinner and overnight. (B, D)

Day 11 – Tuesday, April 28: Navona, Spanish Steps, Trevi Fountain, Pantheon, Paul Outside the Walls, Catacombs

After breakfast we will begin a half day tour of Classical Rome. As Audrey Hepburn and Gregory Peck in the movie Roman holiday you will be amazed by the Spanish Steps, located in the high-end shopping area of the city where all the well-known fashion brands are. You will see Keats and Shelley house, the Barcaccia fountain by Bernini and the Spanish embassy, that gives the name to the steps, where Casanova lived for some time. After a brief walk you will reach the Trevi Fountain. It is by far the most beautiful and popular fountain in the world. Legend holds that you must throw a coin in it to favor your return to Rome. Only few steps away through the little cobbles streets we will reach the Pantheon. This is the best preserved Ancient Roman temple and served as architectural model for dozens of important buildings in the world, such as the Jefferson Memorial and the Pantheon in Paris. Inside the Pantheon you will see the tomb of Raphael and other personalities of Italy that deserved to be buried in such a significant shrine. We will also walk by Ancient Egyptian obelisks that are among the oldest monuments in Europe and cross two charming squares: Piazza Navona & Campo de' Fiori. The former is the location of Bernini's most renowned hydraulic work, the Fountain of the 4 rivers, also featured in the movie Angels and Demons. The latter is home of Rome's most popular daily market selling flowers, fresh fruits and vegetables, spices and much more. After lunch on own we continue our guided tour visiting the 4th century Basilica of St. Paul Outside the Walls, the traditional site of Paul's tomb. We will end our visit at one of the Catacombs, where we view the 2nd and 3rd century fresco paintings. Return at the Hotel for dinner and overnight. (B, D)

Day 12 – Wednesday, April 29: Free day

Today we will have time to explore by ourselves. Dinner and overnight at the Hotel.

Day 13 – Thursday, April 30: Homeward Bound

This morning we transfer to the airport for our flight to the USA.
